

Terms and conditions for The Abu Dhabi HSBC Championship presented by EGA

The 'The Ultimate Golf Prize' is governed by these official Terms & Conditions ('Official Rules'). By participating in the contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the contest, as determined by 'the organisers' (Abu Dhabi Sports Council) are final in all respects.

- Competition details form part of these terms and conditions.
- The winner will be chosen at random.
- Entrants will receive one entry into the competition:

1.1 When they correctly answer the competition question on the Abu Dhabi HSBC Championship Facebook page; AND

1.2 They have liked the Abu Dhabi HSBC Championship Facebook page.

- 1 (one) winner will receive 2 (two) business class flights from their closest destination to which Etihad flies in the winner's home country (any required domestic travel shall be at the winner's sole expense) to Abu Dhabi, VIP entry for two (2) to the Abu Dhabi HSBC Championship from January 17-22, 2018, accommodation (one (1) room) across those dates, and one (1) invitation to play with Rory McIlroy and Dustin Johnson in the Abu Dhabi HSBC Championship Pro-Am.
